- With 600 franchised outlets in 1964, the Colonel sold his interest in the U.S. company for \$2 million.

- KFC opens one restaurant everyday around the world.
- KFC was the first Western fast food restaurant to enter China, opening its first location on Beijing's Tiananmen Square in 1987.

- Taco Bell was founded in 1962 by Glen Bell in Downey, California. The first franchise was sold in 1964.
- Five items were on the original Taco Bell menu tacos, frijoles, bean burritos, tostadas, and Bell burgers. The first taco sold for 19 cents.

Rather than use all of these company names throughout this handbook, you are notified that any reference to the "Company" refers to PMTD Restaurants LLC and all affiliate companies.

This handbook supersedes all previous employer statements, including any previous handbooks, manuals, memorandums, and oral or written statements pertaining to policies described here. It is effective immediately and is applicable to all employees, regardless of their date of employment.

This handbook does not constitute a contract of employment; it does not create property rights in jobs, nor is it an inflexible set of rules and regulations.

The compensation, hours of employment, and all other terms and conditions of employment for all employees are subject to modification by the Company at its discretion.

The Company reserves the right, on a case by case basis, to interpret its stated or usual policies, practices, and procedures when the Company deems it necessary or appropriate. The Company also reserves the right to modify, revoke, suspend, terminate, or change any or all such policies and procedures, in whole or part at any time, without notice. As such, all employees are subject to termination at the discretion of the Company.

These guidelines have been prepared to help ensure that you are aware of the importance we place on the safety and security of our employees and customers, as well as on the protection of the Company's cash and other assets. These guidelines may be revised periodically. The Company reminds employees that they are responsible for being current on Company policies. As an employee of the Company, it is your responsibility to maintain the confidentiality of such. Inappropriate action or misuse of the Company's proprietary and/or confidential information will result in disciplinary action up to and including termination. If you are unsure of how to handle situations involving Company documents, facts, or records, please consult the RGM or DO or an Owner.

Information about the Company's employees (including ex-employees) is private. This includes work schedules, phone numbers, home addresses and any other personal information. Do not ever share this information with anyone.
